CMS Training change

FDR Training Updates Beginning in 2019, the Centers for Medicare & Medicaid Services (CMS) removed the requirement for FDRs to complete CMS-issued general compliance and fraud, waste and abuse (FWA) training on the Medicare Learning Network (MLN). This was finalized through a Final Rule effective June 15, 2018. CMS expects that organizations continue to provide compliance training for the services provided by their FDRs. BUHP will continue to issue annual compliance training packets to our FDRs. We'll also continue to conduct routine monitoring, auditing and oversight of our FDRs. For 2019, BUHP will continue to focus on the following Medicare Program requirements; Standards of Conduct and/or Compliance Policies • US Department of Health & Human Services Office of Inspector General (OIG) and General Services Administration's System for Award Management (SAM) exclusion screening • Reporting mechanisms • Downstream entity oversight • Operational oversight

Updates to BUHP's Compliance Policies and Procedures

We recently updated our Compliance Policies and Procedures. These policies describe our process for ensuring we have an effective Compliance Program. Our FDR's routinely receive these through the initial and annual FDR training communications and are available online. FDRs should implement similar policies or you can adopt ours.
