### **Important Changes to Pharmacy Prior Authorization Grid**

#### **Banner - University Family Care**

Effective January 1, 2023, Banner University Health Plans (B – UHP) will update the Prior Authorization (PA) grid with the changes listed below for Banner – University Family Care/ACC and Banner – University Family Care/ALTCS. ## **Medical Coding Changes & Updates**

The AHCCCS Medical Coding unit has recently updated all the Durable Medical Equipment (DME) Category of Service (COS) 15 and Medical Supply (COS) 40 codes to match the Center for Medicare Services list on DMEPOS. All code ranges have been re-entered into the system as single codes due to the specific COS for the specific code.

Also updated was the DME Place of Service for all DME codes to match current National Coding Standards.

Current guidance states for DME, the place of service billed must be under the POS that the member will use the DME product even if it is dispensed from the provider's office.

**AHCCCS Update**: Place of Service (POS) 11 was added back to V2020-V2799 with no lapse until Sept. 1, 2022 to allow the health plans to work with those providers who are submitting claims incorrectly for this specific code set. V2020-V2799 is a DME product on the DME list. AHCCCS termed POS 11 in June and reinstated in July 2022 to allow providers time to reflect the change in their system until Sept. 1, 2022.

Please use POS 12 or the appropriate POS corresponding to the where the member will use the DME product as outlined above for dates of service(s) after Sept. 1, 2022.

# **Immunization & Injectable Reimbursement**

The Immunization & Injectable Fee Schedule for the Banner Medicare Advantage products will be retired on Dec. 31, 2022.

All Part B Covered Drugs will continue to be reimbursed at 100% of Medicare. Reimbursement for Part D Covered Drugs are processed through the pharmacy benefit.

Providers may bill for Part D Covered Drugs provided in the office through TransactRx. Providers may start registering on the web based Medicare Part D billing system with the following link: https://www.transactrx.com/medicare-part-d-billing

TransactRx allows providers to determine in real time if a patient has Medicare Part D coverage, which Part D plan the facility will need to bill, what the patient's' financial responsibility is for a specific vaccine and how much the physician will be reimbursed. TransactRx will be utilized for all vaccines covered under Part D. The influenza, pneumococcal and Covid vaccines fall under Part B medical benefits. The website will provide a drop down menu of vaccines covered under Part D. Additional details about billing for Part D Covered Drugs will be forthcoming.
